



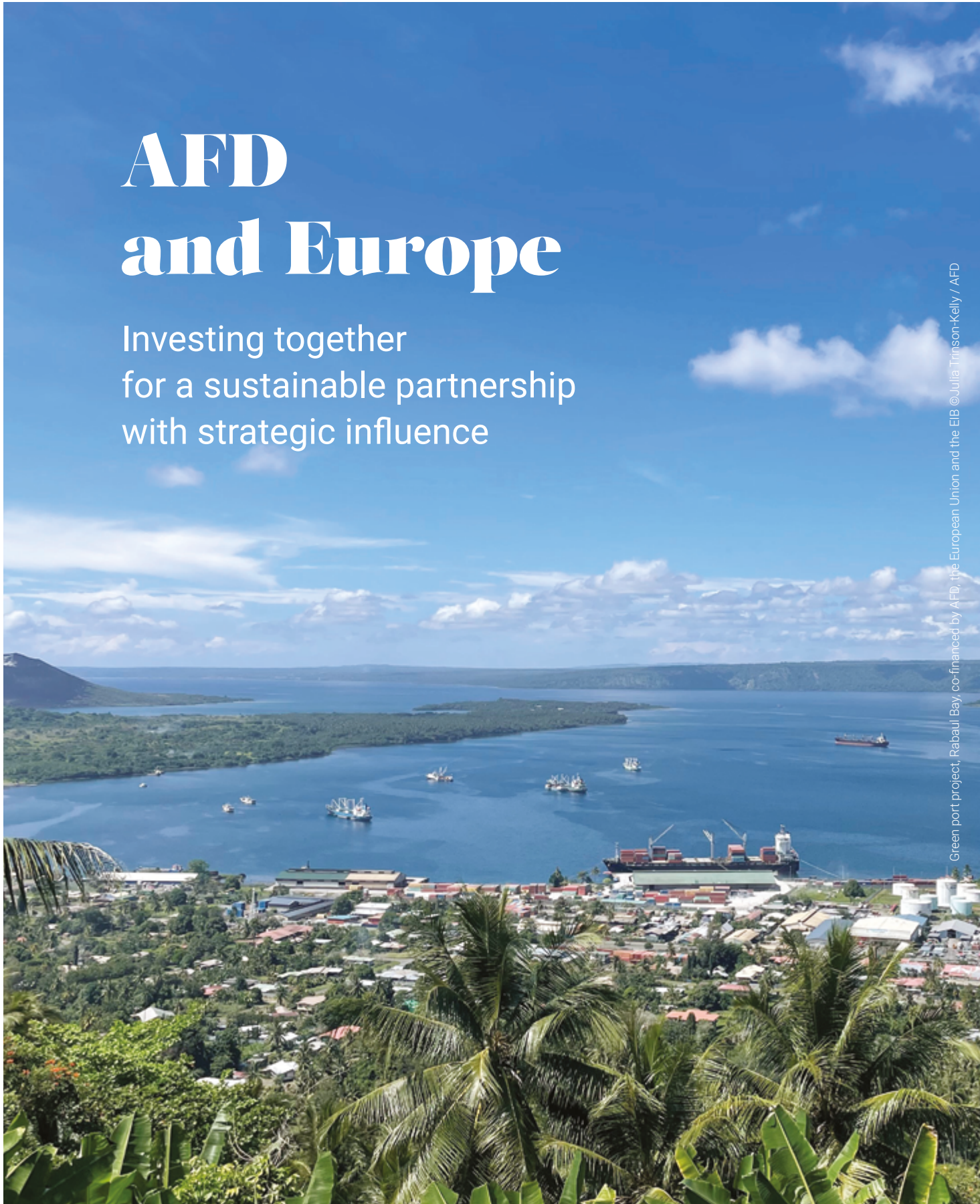

AFD at the heart of European action

Building on nearly 20 years of partnership with the European Union, AFD is progressively aligning its geographic and sectoral priorities with the orientations of EU development policy. These include security, economic competitiveness, cohesion, and the green transition.

For AFD, Europe is a key platform for mobilizing resources for its actions in the priority areas of the Global Gateway initiative, in particular transport, digital infrastructure, clean energy, health sector, and critical minerals.

Our actions aligned with Europe's main geographical priorities

— **In the Middle East and North Africa**, AFD focuses on sustainable infrastructure, critical climate change adaptation, and migration.

— **In Eastern Europe and the Balkans**, AFD is supporting candidate countries in their EU accession and is committed to rebuilding Ukraine.

— **Across the rest of the world (Africa, Asia, Latin America, and the French Overseas Territories)**, AFD is increasing co-financing for projects that fall under the key Global Gateway themes, thereby maximizing a catalytic effect for European companies.

AFD acts within “Team Europe” along with the JEFIC network (which brings together the development banks KfW in Germany, CDP in Italy, AECID in Spain, and BGK in Poland) and with the European multilateral banks (EIB, EBRD, and CEB). AFD thus works closely with many institutions (via Team Europe) to coordinate European investments and speak with a common voice at the international level.

AFD is actively preparing the future 2028-2034 EU financial framework alongside “Team France” and European partners — with a focus on advocating for the open-architecture approach to aid, the EU preference for indirect management of funds, stricter requirements for procurement procedures and rules, the promotion of public-policy loans, continued priority for addressing fragility, and support for SMEs.

By working in collaboration with its European partners, AFD is helping to build a stronger Europe within a world in common.

Energy efficiency for public buildings in Moldova

Financing: A loan of €30 M from AFD, a grant of €38.7 M provided by the German Government through the German Development Bank (KfW), and €4.3 M from the Moldovan government

Beneficiary: Republic of Moldova

Implementation period: 2025-2030



THREE IMPACTS

Stabilizing Moldovan energy systems in response to external shocks

Decreasing energy expenditures in the health and education sectors

Improving public services for 200,000 Moldovan citizens

AFD launched the INSPIREE project to support Moldova in its path to EU membership, as well as in its security and energy transition. The aim of this initiative is to improve the energy efficiency of strategic public buildings, particularly in the health and higher education sectors.

In addition to helping reduce the country's dependence on energy imports, INSPIREE seeks to decrease energy expenditure and to improve the resilience and comfort of renovated buildings. The project is co-financed by AFD and KfW in Germany (illustrating the growing coordination among members of the JEFIC network), and the Moldovan government. It is helping to deliver tangible improvements to public services for

200,000 Moldovan citizens. This partnership, signed during the official visit to Paris by President Maia Sandu, illustrates Team Europe's commitment to the security and modernization of Moldovan infrastructure.

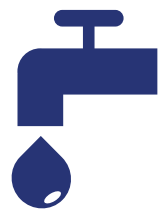
AFD Group has operated in Moldova since 2022, where it has already committed €230 million to accelerate the energy, transport, and environmental transitions.

Program to support Morocco's national water policy

Financing: Three loans from AFD, CDP, and KfW of €100 million each; a delegated European grant of €46.9 million (excluding AFD remuneration); and a €0.4 million grant under the French "Programme 209" to cover costs not financed by EU funds

Beneficiary: Kingdom of Morocco

Implementation period: 2025-2028



THREE AMBITIONS

Budget support combined with extensive technical cooperation

More resilient water management to deal with climate change

A European partnership to sustainably strengthen water governance

Morocco faces a water shortage that has become structural due to the effects of climate change. It has suffered six consecutive years of drought, and its per capita water availability is at a critical level. This new program, financed by AFD and its European partners (the EU, KfW in Germany, and CDP in Italy), provides support to Morocco's national water policy. It contributes to climate adaptation via improved knowledge about water resources, integrated management of water resources and extreme hydrological events (droughts and flooding), sustainable and resilient management of groundwater, and protection of water resources and biodiversity. This is the first JEFIC financing operation involving three European partners. The program also actively supports gender equality in the water sector and works toward reducing industrial pollution to preserve biodiversity. By consolidating the capacities of Moroccan institutions through exchanges of expertise with their European counterparts, this partnership leads to long-term enhancement of those institutions and the water governance framework in Morocco.
